#### **Grants for Projects to Improve Senior Health in Care Facilities**

Funding Source: Patrick and Catherine Weldon Donaghue Medical Research Foundation

Deadline: March 27, 2017 for Letter of Intent

Grants fund researchers for projects that can improve the quality of care and the quality of life for the elderly in nursing homes or other care facilities. Through its Another Look: Better Health for Elders in Care Facilities program, the Foundation will award grants totaling \$\$750,000 to up to six projects that address, with existing data, a particular problem affecting the elderly in care facilities. Grants support established research scientists of all ages working at accredited institutions in the United States. Applications will be judged on the scientific merit and the innovative aspects of the proposal as well as on the competence of the applicant. Research grants of up to three years will be provided. A renewal grant with a maximum of two years is possible, but it will be awarded on a competitive basis. Research grants will not be awarded to investigators who have already received, or expect to receive, substantial support from other sources, even if it is for an unrelated purpose. Research grants normally range from \$30,000 to \$75,000 per year. The Grants-in-Aid program is designed for researchers at the assistant professor level who experience difficulty in competing for research funds because they have not yet become firmly established. Grants-in-Aid can also be made to senior scientists. All applications will be judged on the scientific merit and innovative aspects of the proposal, as well as on past performance and evidence of the applicant's continued productivity. Grants-in-Aid are awarded for a one-year period and do not exceed \$30,000.

## **Grants for Professional Development Programs to Improve Instruction for English Learners**

Funding Source: United States Department of Education

Deadline: April 24, 2017

Grants are awarded on a competitive basis, for a period of not more than five years, to institutions of higher education (IHEs) or public or private entities with relevant experience and capacity, in consortia with State educational agencies (SEAs) or local educational agencies (LEAs). The purpose of these grants is to provide professional development activities that will improve classroom instruction for English learners (ELs) and assist educational personnel working with such children to meet high professional standards, including standards for certification and licensure as teachers who work in language instruction educational programs or serve ELs. The Department is particularly interested in supporting projects that improve parental, family, and community engagement. The Department is also interested in supporting dual language acquisition approaches that are effective in developing biliteracy skills.
