# **Grants for Aquaculture Research**

#### Funding Source: US Department of Agriculture

Deadline: May 17, 2016

Grants offered by the Aquaculture Research program support the development of an environmentally and economically sustainable aquaculture industry in the U.S. and generate new science-based information and innovation to address industry constraints. Over the long term, results of projects supported by this program may help improve the profitability of the U.S. aquaculture industry, reduce the U.S. trade deficit, increase domestic food security, provide markets for U.S.-produced grain products, increase domestic aquaculture business investment opportunities, and provide more jobs for rural and coastal America. The Aquaculture Research program will fund projects that directly address major constraints to the U.S. aquaculture industry and focus on one or more of the following program priorities: (1) Genetics of commercial aquaculture species. (2) Critical disease issues impacting aquaculture species. (3) Design of environmentally and economically sustainable aquaculture production systems. (4) Economic research for increasing aquaculture profitability.

# Grants for Research, Conservation and Education Focused on Threatened Ocean Wildlife

#### Funding Source: Save Our Seas Foundation (SOSF)

Deadline: May 31, 2016 for Letter of Intent

Grants funded by the Save Our Seas Foundation support research, conservation and education projects worldwide, focusing primarily on charismatic threatened wildlife and their habitats. SOSF is particularly interested in Sharks, Rays and Skates. A special call for applications for 2017 for this Keystone Grant program (\$10,000 - \$100,000) is aimed at supporting research projects that promote the recovery of Sawfish. The SOSF's Small Grant program (<\$10,000) is aimed at early career scientists for short and small projects dedicated. Only Chondrichthyes species (sharks, rays, skates, sawfish and chimaeras) or habitat-related projects will be considered.

### Grants for Research and Evaluation on Victims of Crime

Deadline: June 03, 2016

Grants offered by the collaboration of **t**he National Institute of Justice (NIJ) and the Office for Victims of Crime (OVC) fund four areas of research that are of interest to both agencies. These topics include:

1. Victim-Offender Overlap.

2. Secondary Data Analyses that Improve our Understanding of Violent Victimization Experiences of At-Risk Groups.

- 3. Research on Restorative Justice Practices With Victims of Crime.
- 4. Financial Costs of Crime Victimization

NIJ estimates that it will make up to two (2) awards per focus area of up to \$750,000 per award for a 24-36 month project period, beginning on January 1, 2017.

- **identify a project or initiative** they intend to develop during the fellowship and are able to articulate how this experience will help them meet that goal and create positive impact; and
- **commit to engage actively** with the global Eisenhower Fellowship network throughout their lifetime.

Interested candidates apply for **one** of three programs: USA Fellowship; Zhi-Xing China Eisenhower Fellowship; or EF Agriculture Program.

## **Grants for Arboriculture and Urban Forestry Research**

#### Funding Source: Tree Research and Education Endowment Fund (TREE Fund)

Deadline: October 01, 2016

Grants of the TREE Fund's Jack Kimmel International Grant Program provide much needed funding to arboriculture and urban forestry researchers all over the world. This grant is administered by the TREE Fund, with participation from the Canadian TREE Fund in the evaluation process. Projects are expected to be completed within one to three years. Grant award amounts are limited to a maximum of \$10,000 and will vary depending upon the adjudged value of the project relative to the needs of the arboriculture community. TREE Fund requires a match of at least 10% cash or in-kind. No project may receive more than one award from this program. No university or institutional overhead expenses may be funded by this grant.
