Grants for Arts Envoys

Funding Source: Department of State

Deadline: May 27, 2016

Grants of the Arts Envoy Program annually enable approximately 200 American artists and cultural experts (known as Arts Envoys) to travel abroad for individual programs or as part of an ensemble or group to engage and consult with key foreign audiences through performances, workshops, meetings, seminars, and appearances in foreign media. By addressing topics identified and developed by U.S. Missions (generally U.S. Embassies and Consulates) worldwide in cooperation with ECA, the program promotes an understanding of U.S. policies and institutions, and the political, economic, social, and cultural context from which they arise. Arts Envoy individuals and groups are programmed in one or more countries with a variety of audiences from a wide range of disciplines in the cultural arena, including in the performing and visual arts, and in arts management, as well as with museum professionals and other cultural experts. Arts Envoy programs range from five days to six weeks in length.

Grants for Internationalizing Teacher Preparation

Grants of the Internationalizing Teacher Preparation program of the Longview Foundation fund efforts to expand teachers' global knowledge and skills. Preference will be given to those teacher preparation institutions that are connected to state or citywide changes in order to have a more systemic effect and to those using online courses for pre-service education or professional development. Proposed projects are reviewed with particular attention to: partnerships and collaborative activities between institutions to further ensure impact and sustainability; integration of global dimensions into pre-service teacher education, both in pedagogy and subject matter; financial support for continuation of activities beyond the grant period to assure sustainability; clear commitments to work with the relevant state education agency and/or local school districts; and dissemination plans to encourage replication at other institutions. The foundation is interested in supporting activities that have other sources of funding and can demonstrate sustainability beyond the grant period.

Grants for Academic Research

Grants offered by NIH's Academic Research Enhancement Award (AREA) program will stimulate research in educational institutions that provide baccalaureate or advanced degrees for a significant number of the nation's research scientists, but that have not been major recipients of NIH support. AREA grants create opportunities for scientists and institutions otherwise unlikely to participate extensively in NIH research programs to contribute to the Nation's biomedical and behavioral research effort. AREA grants are intended to support small-scale research projects proposed by faculty members of eligible, domestic institutions, to expose undergraduate and/or graduate students to meritorious research projects, and to strengthen the research environment of the applicant institution.

Grants of the Spencer Foundation's Lyle Spencer Research Awards program support intellectually ambitious, large-scale education research projects with budgets between \$100,000 and \$1,000,000. This program encourages proposals initiated by scholars across a variety of disciplines and fields in an effort to create much-needed space for creative and ambitious research projects that promise to advance understanding of educational practice and its improvement. Funded initiative will fall into one of three broad categories.

- Studies that focus more or less directly on teaching and learning processes themselves, at the classroom level (or in instructional settings outside classrooms).
- Studies that pay attention to the larger policy and institutional environments within which
 educational transactions take place. A key interest here is attention to the conceptual and
 empirical links between elements of the infrastructure and the actual character of educational
 practice. Studies that aim at better understanding how different ways of defining, measuring,
 and rewarding teacher performance affect teachers' professional goals, time use, and
 understanding of success would fall into this category.
- Studies that help develop research tools that can support advancing the kinds of research identified here. The development of improved measurement tools, stronger theoretical frameworks and analytical methods, and the development of new databases and the archiving of data bases
