Committee on General Education Report to the Undergraduate Curriculum Committee

- 1. COGE considered a course proposal for <u>CEP 215</u> as an SB course. After extensive discussion we elected not to act on the proposal in its present form.
- 2. COGE approved a revised Writing in the Discipline statement for <u>Justice Studies</u> (presented by Tanni Chaudhuri) with the expectation that language will be revised to include the concept of scaffolding. The FYW descriptions serve as a good model.
- 3. Maureen Reddy presented the extensive Report on Summer Assessment. COGE approved moving forward with the recommendations that require no formal action. Other ideas will appear on future agendas for UCC consideration.
- 4. Becky Caouette reported on some innovations in First Year Writing.
- 5. Maureen Reddy reported on the status of First Year Seminar and outlined some logistical changes related to the summer assessment report.
- Course Enrollments Fall 2018 (Comparison with Fall 2017) are down from fall 2017, but the number of sections has not declined as significantly, resulting in some inefficiencies.
