Comments: \#006 is a request to delete a number of courses that have not been taught in three or more years from the catalog--namely: ANTH 215 The Archaeology of Ancient Civilizations and ANTH 337 Anthropological Approaches to Religion; ART 226 Pixelbased Digital Design and ART 227 Vector-based Digital Design; GED 263 The Holocaust and Genocide, GED 264 Multicultural View: Same Sex Orientation and Transsexuality, GED 265 Disability viewed through Cross-Cultural Lenses, and GED 268 Bullying Viewed from Multicultural Lifespan Perspectives; HPE 335 Consumer Health; HIST 347 Foreign Relations of East Asia in Modern Times; INST 251 Introduction to Emerging Technologies; MATH 262 Ethnomathematics (GE-core4); PFA 158 Experiencing the Performing Arts (GE-A); SWRK 452 Social Work Practice: Mental Health; SOC 312 Class, Status and Power, SOC 331 The Individual and Society, and SOC 346 Underworld and Upperworld Crime and Criminals; SPAN 110 Review of Basic Spanish, and THTR 405 Readers Theatre. The programs that are affected are: Global Studies uses HIST 347 (elective), as does the ELED Social Studies concentration; Justice Studies uses SOC 346 (elective); Theatre Major with Concentration in Performance uses THTR 405 (elective), HPE 335 was one of the required electives in the Community Health and Wellness concentration in Community and Public Health, and ANTH 215 was an elective in the ELED Multidisciplinary and Social Studies concentrations. The four GED courses are also listed as current GE Connections courses. \#007 requests the deletion of three CUS that were offered but have attracted no students since they were approved, namely: Risk Management and Insurance since 2011, Computed Tomography since 2012 and Youth Services since 2013.

Comments: A collection of proposals seeking to switch the prefixes of a group of current NURS courses to the more appropriate HCA for whose programs they are actually being used. NURS approves of this switch and would like the old NURS courses to be deleted from the catalog. Thus in \#013, NURS 201 becomes HCA 201 Introduction to Health Care Systems, and when offered is being switched to the Fall. In \#014, NURS 302 becomes HCA 302 Health Care Organizations and the prerequisite will be updated to HCA 201. In \#015, NURS 303 becomes HCA 303 Health Policy and Contemporary Issues and the prerequisite will be updated to HCA 201. In \#016, the prerequisite of HCA 355 Quality Management needs to add HCA 302, and change when offered to Fall and Spring. In \#017, NURS 401 becomes HCA 401 Ethical and Legal Issues in Health Care Management, and the prerequisite will be updated to HCA 201 or consent of instructor. In \#018, NURS 402 becomes HCA 402 Health Care Informatics, and in \#019 the prerequisite of HCA 467 Internship in Health Care Internship in Health Care Administration will update the prerequisite to ensure the students are ready for the course: "Student must have completed all major and cognate courses in the major (except for electives and HCA 461), or be concurrently enrolled in any outstanding courses, or have permission of program director." Updates on various Health Sciences concentrations, Community Health and Wellness concentrations, and Health Care Administration major and minor programs will be made to reflect these changes, as well as the prerequisites of ANTH 309.

Comments: A collection of proposals seeking to update requirements for the Health Education, Physical Education and Community Health and Wellness programs. The goal is to add some new courses and combine material from others to create better syllabi that cover state teacher requirements yet reduce the number of courses students must take (while still covering all the necessary material), especially in areas that double majors in Health and Physical Ed. had found previously overlapped. \#020 requests revisions to the Health Education, Physical Education and Community Health and Wellness programs to add new courses, and switch others around to better serve all majors. Revised courses mostly need updated titles and descriptions to reflect their improved coverage. \#021 HPE 140 Foundations of Wellness and Health Promotion, \#024 HPE 243 Motor Development and Motor Learning, \#031 HPE 404 School Health and Physical Education Leadership, all need new titles and descriptions. In addition to these, \#033 HPE 413 Practicum in Elementary Physical Education and \#034 HPE 414 Practicum in Secondary Physical Education, \#036 HPE 417 Practicum in Elementary Health Education, all need new prerequisites (and HPE 413 and HOE 417 will change when offered for better sequencing). \#023 HPE 233 Social and Global Perspectives on Health needs a new title and description, and to add a summer offering. \#026 HPE 301, \#030 HPE 325, and \#032 HPE 409 all need revised prerequisites and HPE 325, when offered. \#035 HPE 415 Teaching/Assessment in Adapted Physical Education just needs a revised description and prerequisites. \#025 asks that to align credits with other practicum courses, HPE 300 is decreased by one credit. \#037 HPE 418 Practicum in Secondary Health Education needs a revised title, description, prerequisites, when offered, and to be decreased by one credit. The new courses they would like to include are \#022 HPE 200 Promoting Health and Well-Being in Schools, \#027 HPE 313 Elementary Activities, \#028 HPE 314 Middle School Activities, and \#029 HPE 315 High School Activities.
