Comments: #212 Revises the Secondary Education program in History and Social Studies. The discipline part of the major will go down from 56-58 credits to 46, largely due to the reduction of HIST courses from 4 to 3 credits, thus helping offset the new education courses students will be required to take. Additional certification courses have also been reduced and streamlined in terms of options. The whole program will go from 90-92 total credits to 91. #344 Revises the Secondary Education program in Social Studies. The discipline part of the major will go down from 55-58 credits to 46-49, thus helping offset the new education courses students will be required to take. Concentration courses have been reduced from two to one. The whole program will go from 89-92 total credits to 91-94. #341 and #342 ask to approve two new practicum courses to be used for both of these programs: SED 314 Responsive Social Studies Teaching/Learning I and SED 414 Responsive Social Studies Teaching/Learning II. #343 asks to approve the creation of FNED 461 LatinX in the United States as a crosslisted course with the existing ANTH 461; same course but can be offered more frequently (graduate students also take this course as ANTH 561/FNED 561)-all versions having the title and description updated to reflect non-gendered terminology.

The other proposals facilitate this merge by updating titles, descriptions and prerequisites. #296 revises the title and prerequisite (drop COMM 251) of COMM 301 Introduction to Public Relations, #297 revises the description and prerequisite (drop COMM 201) of COMM 311 Advanced Public Relations, #298 revises the title, description, prerequisites (drop COMM 201 and add COMM 334), and changes when offered of COMM 312 Advanced Writing: Public Relations and Advertising, #299 revises the title and prerequisite (drop COMM 240 and add 45 credits) of COMM 334 Introduction to Advertising, #300 revises the title, description, prerequisite (dropping COMM 301) and when offered of COMM 335 Research for Public Relations and Advertising, #304 are deleting COMM 376 Advertising Lab and COMM 377 Public Relations Lab, as #305 creates a new combined lab experience: COMM 485 Public Relations and Advertising Campaigns.

It will keep the same courses it currently uses, so the total credits remain the same, though the courses will be differently listed, and it will include new admission requirements. #337 asks to approve revisions to the title of an overall program and to one of its concentrations: Community and Public Health Promotion (CPHP) will replace Community Health and Wellness (CHW), and its Community and Public Health Promotion concentration, will become the simpler Public Health Promotion.

Also updating the language to explain the Specialization in Adapted Physical Education and deleting then *"alternative" option.* The others revise titles, descriptions and prerequisites and create two new courses for the program. #309 revises the title and description of HPE 140 Foundations: Physical Education and Exercise Science; #310 revises the title, description and prerequisite (dropping HPE 300 option) of HPE 325 Assessment in Physical Education, and reduces it by one credit; #311 revises the prerequisite for HPE 409 Adapted Physical Education to switch from SPED 433 to SPED 333; #313 revises HPE 425 Student Teaching in Physical Education to reduce it by one credit and revise the prerequisite to include HPE 435 too be take concurrently; #315 revises the title. description, and prerequisite of HPE 444 Practicum in Adapted Physical Education, as well as reduce it by one credit to be just 2 credits, and change when offered to become a required course in PE major. #312 and #314 are the new courses: HPE 416 Educational Kinesiology and Exercise Physiology and HPE 435 Physical Education Student Teaching Capstone.

(formerly only 4 did this). #318 wishes to suspend the Art Education BFA program for possible future revision. #324 revises ARTE 426 Student Teaching in Art Education, to update the description, prerequisites, when offered and reduce number of credits from 10 to 7, and #325 revises ARTE 464 Student Teaching Seminar in Art Education to update the description, prerequisites, when offered and increase number of credits from 2 to 3. #319 to #323 are the new courses: ARTE 301 Art Education Concepts and Contexts, ARTE 302 Art Curriculum Design and Assessment, ARTE 407 Elementary Practicum on Art Education, ARTE 409 Secondary Practicum on Art Education, and the early spring course ARTE 420 Introduction to Art Education Student Teaching.

Finally, #332 revises BIOL 443 Fundamentals of Neurobiology to remove its cross-listing, update its prerequisite, and change when offered. This one also deletes NEUR 443 Fundamentals of Neurobiology and NEUR 460 Current Issues in Neuroscience as they were created for a program that does not exist.

HIST 357 will be able to be repeated once for credit. CUS will go from 17-21 credits to a fixed 18, and the Minor from 21-25 to 19.

The others revise titles, descriptions and prerequisites and create four new courses for the program. #346 revises HPE 200 Promoting Health and Well-Being in Schools, to remove the prerequisite; #350 revises the title of HPE 410 Managing Stress and Mental/Emotional Health; #351 revises the prerequisite for HPE 417 Practicum in Elementary Health Education to become HPE 300 or consent; #352 revises the description of HPE 422 Student Teaching Seminar in Health Education, to drop to 9 from 10; and #354 revises the prerequisites for HPE 410 Nutrition Education and Promotion, HPE 326 Assessment in Health Education and Promotion, HPE 340: Sexual Health Education and Promotion, and HPE 434 Health Education Student Teaching Capstone to be offered in Early Spring.

The others revise titles, prefixes, descriptions and prerequisites on courses used for the program. #365 revises TECH 305 Teaching and Learning in Technology Education, to revise the title, course number (was 300), description, when offered, and prerequisites. #366 revises the numbers and titles of the old TECH Ed. practicum courses (TECH 407/408) to become TECH 318 Practicum I: Teaching K-6 Technology Education, and TECH 418 Practicum II: Teaching Secondary Technology Education Grades 7-12 and also revise the descriptions, when offered, and prerequisites. Comments: #368 and #369 asks for two new 2 credit courses for use in the ELED Mathematics program: ELED 238 Teaching Functions and Algebra and ELED 248 Teaching Data and Statistics. #370 asks for revisions to the ELED Math program to include Middle level certification, and add in the new and revised Education courses and make other changes to keep the program current and at an acceptable credit limit; it will increase from 103 to 122 credits (20 of these double-count with Gen Ed.); this is listed as a 4 ½ year program, and offers a double teaching certification. This proposal also revises the prerequisites of ELED 437 Elementary School Science and Health Education to be better in line with the decided program science cognates. #371 asks for revisions to the ELED General Science program to include Middle level certification, and add in the new and revised Education courses and make other changes to keep the program current and at an acceptable credit limit; it will increase from 93 to 115 credits (20 of these double-count with Gen Ed.); this is listed as a  $4\frac{1}{2}$  year program, and offers a double teaching certification.
