Comments: #15-16-004 requests that all of the Medical Imaging programs and BS in Health Sciences (Human Services Concentration) use the new COMM 338 Communication for Health Professionals course in place of COMM 330 or 336, as a more appropriate choice for the disciplines. #15-16-005 asks for prerequisites to be added to HSCI 466 Evidence Based Decision Making for Dental Hygiene to ensure students are properly prepared for the course. These are courses already required for the major so will not affect the credit total, but will direct students toward a better sequence. #15-16-006 would like to expand the BS in Medical Imaging concentration: Certified RT Management, to allow it to include DMS, MRI and NMT licensed practitioners. It will be retitled BS in Certified Medical Imager Management, and include additional BIOL courses as cognates for some concentrations.

Comments: The request is to add two courses to the Justice Studies minor that were previously not listed—POL 202 and SOC 207--but required prerequisites for courses that were included. The aim is to avoid such hidden prerequisites so the students are given a clear guide as to how many courses they will need for the minor. While this raises the total from 18-20 to 26-28, four of those credits can be offset because either of these additions can double as the student's general education SB course and so the minor will remain within UCC guidelines.
