Comments: Asks to approve a new course PBAD 326 Public Sector Information Systems, to be used as a replacement in the Public Administration program for the CIS 251 course that was recently deleted. This new course will be better tailored to the needs of PBAD majors than anything else CIS offers, and they have been consulted on the issue. The new course is one credit more than the old CIS one, so the total credit for the major will be raised by one, from 40-43 to 41-44 (but eight of those credits double count as they are Gen-Eds. so the chance for a double-major is still viable).

Comments: Asks to approve a new course HPE 309 Exercise Prescription to be included as a required course in the Wellness and Movement Studies concentration of the CHW program. This will raise the total credits from 82-84 to 85-87, which is within the same range as other concentration choices (these run to 84-88, 85-88, 78-81 and 86-88). However, there will be a forthcoming proposal that overhauls the CHW programs to try and reduce the total credits of each of the concentrations, which are all a little high. #091 and #092, meanwhile, are new courses HPE 244 Group Exercise Instruction, and HPE 310 Strength and Conditioning for the Athlete, to be included as a required electives in the Wellness and Movement Studies concentration of the CHW program.
