Comments: These proposals present a new concentration in the BS in Health Sciences in Food Safety. This is the result of a growing need in the State for specialists in this area, and hopes to be a popular choice and great addition to RIC's offerings. While several of the food safety specialist courses it requires will be taught by adjuncts, initially, if the program grows there may be a future need to hire full time faculty. #001 outlines the concentration, and the rest of the documents cover the new courses that will be required: #002 HSCI Introduction to Food Safety, #003 HSCI Food Plant Sanitation, #004 HSCI 202 Fundamentals of Food Safety, #005 HSCI 300 Food Chemistry, #006 HSCI 302 Hazard Analysis and Critical Control, #007 HSCI 400 Quality Assurance of Food Products, #008 HSCI 403 Food Bourne Disease, #009 HSCI Food Microbiology, #010 HSCI Food Safety Case Study. With the inclusion in the concentration of the already established HSCI 494 Independent Study in Health Sciences, there will also be opportunities for those taking this to pursue internships in the field of food safety.

Comments: These four related proposals request adjustments to the Management and Marketing programs to better serve those enrolled in these majors. #011 would like to change the Math requirements to reflect recent changes in Math offerings, instead of taking three 3 credit Math course all MGT and MKT majors will now be required to take two 4 credit courses (MATH 171 and MATH 248) which will give them the Math skills they need. #012 requests for MGT 322 Organizational Behavior to be added as a restricted elective to the Operations Management Major. #013 wishes to eliminate ECON 314 as a requirement for the General Management major, and #014 would like to move ECON 313 from a requirement to a restricted elective for General Management.
