- New General Education proposals may be reviewed by Council for approval.
- Catalog printing discussion related to implementation of changes made during fall and spring Catalog schedule for printing is March 1st. This date makes it difficult to get late changes into catalog and creates havoc for advisers.

Suggestion: Catalog is published biannually, making it difficult to track changes, so instead of this, create an annually published Notebook style catalog which would be better for advising purposes, and updates could then be made annually. Further suggestions for consideration:

- 1. Absent any exceptional circumstances, all proposals to be implemented only in the fall;
- 2. Most likely, April will be the latest date possible to make changes to catalog, in order to meet publication requirements for incoming students.
- 3. The Notebook catalog will be economically printed in-house.
- 4. The notice for date/semester of implementation will appear prominently on the proposal forms.
