The discussion related to the program change included revisions to the Mass Media Concentration and the Public Relations Concentrations in the Communication Program.

- Phil Palumbo, et.al. described the need to keep students up-to-date in the communication field because of the unparalleled change in media and communication technologies. The program is revising its emphasis in Mass Media so that students will be able to gain skills that utilize digital media production. The curriculum will also provide students with enriched methods to analyze mass media from a variety of theoretical perspectives.
- COMM 302 & 312 were developed to replace course work that was provided by the English
  Department. Those courses are no longer offered. In response the COMM program replaced
  them with COMM 302 Writing for News and Public Relations & COMM 312 Advanced
  News and Public Relations Writing.

Raimundo Kovac described the rational for the revisions to the program. Additional credit hours to the courses will allow students to learn concepts in-depth, and have more contact time with instructors. The additional time will allow instructors to add important content to course work that might not otherwise be undertaken. The prerequisite for course work beyond MATH 300 (A grade of C or better) will insure that students won't struggle in their core classes. Emphasis on proofs and proof writing will strengthen student mathematical skills. The extra credit hours will also give students and instructors time to interact more closely with constant feedback. (Friendly edits will be reflected in new catalog copy)

# Report of the Committee on General Education to the Rhode Island College Curriculum Committee

## May 20, 2011

COGE chair James Magyar was on sabbatical in the spring of 2011. I served as his sabbatical replacement this semester. He will be returning to COGE this coming fall.

At the beginning of the spring, COGE was "on hold" while the General Education Task Force (GE-TF) worked to put together revised outcomes and a new structure for the general education program here at RIC. The following page shows a timeline of the general education events from this spring. After the GE-TF submitted its draft proposal, they hosted three open meetings with faculty. COGE members were encouraged to attend these meetings, which were held on March 29, 30, and April 1. Their final draft was submitted April 21, and their final report with recommendations for assessment was submitted on May 3<sup>rd</sup>. Task force members worked hard since September on the proposal and deserve our thanks.

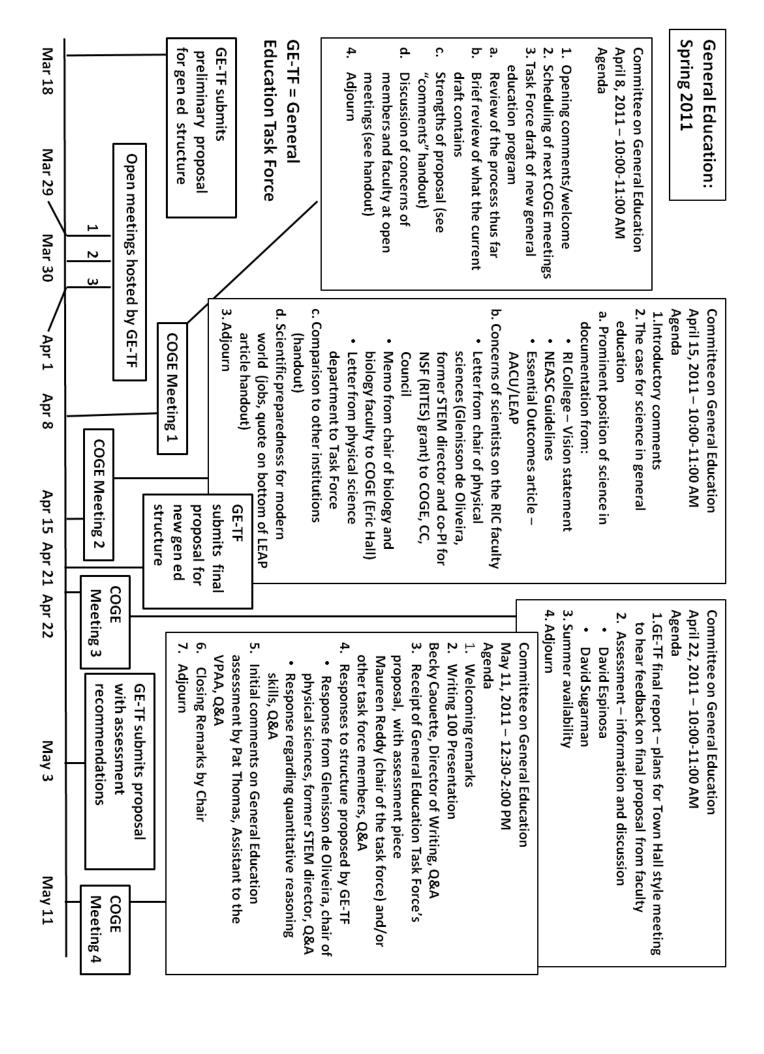
COGE had four meetings in April and May, as shown on the timeline. Agendas for these meetings are also given on the next page of this report. All these meetings dealt with the new proposal, though there was only one meeting after the final version with assessment recommendations was submitted (submitted May 3<sup>rd</sup>, COGE meeting May 11<sup>th</sup>).

At its last meeting, on May 11<sup>th</sup>, COGE officially received the final report of the task force, including the recommendations for assessment. This meeting was well attended by faculty. Many TF members were there as well as many who were neither members of COGE nor of the TF, but simply came out of interest in the process. There were over forty people present at the meeting, representing more than thirteen departments. The fact that such a large group of faculty came to a COGE meeting at the busy end of the semester, in the middle of finals week, shows that RIC faculty are keenly interested in general education and willing to dedicate their time to a

healthy and energizing discussion. While I will not be chair this coming fall, I look forward to participating in fall meetings on the subject of general education.

Although the College Honors Program is not a subcommittee of, nor does it report to, the Curriculum Committee, you did request that I inform you regarding any activities or actions in honors that might be of interest to the Committee. I am, of course, more than happy to comply.

The thing that first comes to mind is Departmental Honors. On May 3, the Honors Program sponsored a Poster Session and an Awards Dinner for students graduating with Departmental Honors. The events were successful but raised issues that I may ask the Curriculum Committee to consider next year. While the awarding of Departmental Honors is the responsibility of the respective departments, there does need to be some uniformity among departments in terms of reporting, due dates, library submissions of completed projects, and the like. At the moment, there seems to be a certain amount of confusion about such things. I will be in conversation with departments and will draft suggested guidelines over the summer. Also over the summer, I will complete the review of information on honors on departmental websites that I began this semester.

The other major item on the horizon is, of course, General Education. Once the college has adopted a new General Education Program, I will begin work on a revised General Education Honors Program to be submitted to the Curriculum Committee for its approval. I hope that that process can be completed by Spring, 2012.
