- Currently, we have four documented definitions for mode of instruction, but we only use three;
- We need to ask student advisors if these definitions sufficiently make clear to students what they are registering for;
- Does the description for hybrid courses provide a description of the maximum amount of time spent on-line or F2F?
- Definitions should not allow instructors to change the mode of the class once the course is running;
- Need to resolve issues for Hybrid Instruction and Hybrid Testing;
- We will use three definitions, but we may have to rework them further to insure clarity.
- Other concerns included the point that classes are scheduled one year in advance; creates an issue if a section wants to become hybrid.
- Scheduling of rooms for hybrid classes; are two classes able to share a room if both are hybrid? This is something the college is working to be able to schedule.
