## Other new business:

 Discussion of math competency: apparently some students are coming in with upper-level math and being told they need to take math competency. May need to look at articulation requirement, but general feeling is that other college's equivalents of our MATH 139 should not be accepted as qualifying for math competency, and most other MATH courses are accepted. RIC requirements for this are: certain SAT or ACT scores, or equiv. of MATH 010, or equivalent of MATH 177 **or higher** (the only ones not accepted would be MATH 120 or the MATH 143/144 sequence). Admissions needs to make sure they're updating the math competency when students are transferring. So it was felt there is no need to intervene, just ensure the current rules are being followed.

- Also, it was pointed out that the current catalog has dropped all references in course descriptions to the number of contact hours for courses where these differ from the number of credit hours. This is useful information for both students and admin., therefore we will look into getting this reinserted.
