Attributes of Professional Behavior:

As a major in the Health and Physical Education Department, I strive to......

I. Professional Identity and Continuous Growth

- 1. Maintain a positive attitude in academic and professional settings (school and community organizations, conferences, etc.)
- 2. Demonstrate a professional appearance.
- 3. Act on constructive verbal and/or written feedback from others.
- 4. Conduct self-assessments through reflection to overcome limitations and enhance strengths.
- 5. Demonstrate self-initiated learning, either individually or in a group setting (ability to work in a timely manner with classmates toward a common goal).
- 6. Communicate effectively and appropriately (verbal, non-verbal, and written).
- 7. Show punctuality in meeting academic and professional obligations (e.g. assignments, meetings).
- 8. Maintain academic integrity (e.g. does not plagiarize own or others' work, does not share confidential material with others).
- 9. Demonstrate positive professional interactions with instructors, supervisors, peers and intended audience (including but not limited to classroom settings and placements).

II. Academic Performance

- 1. Attend class regularly, staying within allowable absences without arriving late/ leaving early.
- 2. Come to class well prepared to be an active participant (e.g. readings, homework assignments, class materials).
- 3. Demonstrate knowledge of course content on assignments, assessments or when working with others.
- 4. Demonstrate appropriate writing skills in the profession (including online communication).
- 5. Produce high quality assignments that are submitted on time.
- 6. Make prior arrangements with the professor when extenuating situations arise.

V. Collaboration

- 1. Respond respectfully to individual perspectives and differences of others.
- 2. Engage in culturally responsive practices in interactions with learners, families, peers, instructors and others.
- 3. Share information and ideas with others.
- 4. Assume equal responsibility for completing requirements for group projects.
