### **Selected Deanly Initiatives: Rhode Island College**

\* Led successful effort to revise MFA Theatre program with local theatre companies and Trinity Rep Co. following Trinity's sudden consortium with Brown in Spring 2001 – Creating MFA: Performance and Society program, with 23 students in three year program by 2006/07; five grads in 07.

\* Led successful effort to create MA in Art with Concentration in Media Studies, and build initial class of 12 (1999-2000)

\* Initiated the idea for a "Teaching with Technology" faculty development program in May 1998. When the program was endorsed but not funded, campaigned to challenge Office of Higher Education and each President within the Rhode Island system to contribute \$10,000 to start the program as "Teaching with Technology Fellows" Program in Spring 1999. Program renewed by OHE for three successive years at well over \$100,000 per year, focus on Web CT.

- \* Secured in 2006, a three year seed grant of \$139,000 from the U.S. Department of Education and successfully created a minor and certificate program in International Non-Governmental Studies (INGOS), along with annual international conference, and Carnival of Cultures with especial focus on Francophonie, Spanish and Portuguese heritage communities and internships overseas in countries where such languages are spoken.
- \* Saved undergraduate French Program along with 8 other low completion programs (e.g., BA, Physics, MA, Psychology; MA, Biology; BS, Computer Science; MA. History).
- \* Secured grant from the French-American Cultural Exchange to run a 6 film Tournées Francophonie Film Festival on the theme of "Legacies of Colonialism and Cultural Politics."
- \* Initiated October Series in 1991 by securing the North American premiere of the controversial exhibition, "The Worth of the Human Being: German Medicine, 1918-1945" with funding from the Goethe Institute, Boston. Over 1,200 spectators visit the Bannister Gallery – a record. Four related colloquium also well attended. The success fo the October show leads to enthusiastic support for continued provocative October shows serving as a pivot for month long colloquia, lectures performances, and films. As of October 2008, we reached October Series #19. Themes have ranged from "Children on the Streets," "Borders," "Tribalism and Post-National Identity," "Living with Aids," "Diasporas and INGOs" and "Dark Dream: INGOs in Cambodia" to "Art and Politics in an Era of Globalization," "Green Ethics and Aesthetics," "Modernism and Soul," "Labor at Century's End," "New Media," "Engaging the Speculum."
- \* Initiated successful "Artist and Society" Learning Community for Fall 2002 wherein 24 students in art, music, dance, theatre, film and writing take Writing 101 and History 161 together, along with a Freshman Seminar wherein artistic themes regularly raised. Associated dormitory space also secured. Two New York City museum trips included.
- \* Followed this up with a three semester "CareGiving and Society' Learning Community with Nursing in 2003; also still continuing. And for 2008/09 initiated a two semester "Science and Society" Learning Community.
- \* Administered twenty six undergraduate and ten graduate programs.
- \* Developed successful six credit summer program, "The London Course" with ten to fifteen students, per summer successful running since 1994: Pol 444: British Politics and Subcultures (Summer Session I) and Pol 445 European Pol. Geography (3 weeks abroad in London, Paris and Budapest).
